

## CROSS INSTITUTIONAL STUDY (EXCHANGE) PRE-APPROVAL

For use by current UNSW students who have been nominated for a <u>Short Program – Exchange</u> place by the Outbound Short Program Team in the UNSW Study Abroad and Exchange Office.

#### INFORMATION

- This form is to request pre-approval to undertake a short program at international exchange partner and, on successful completion of the course, for this study to be counted towards the student's current degree program at UNSW.
- Short Program Exchange place will be for a reciprocal exchange place at the partner institution.
- Students will be enrolled in a UNSW EXCH course and pay tuition fees to UNSW.
- Applications will only be considered for students with a Good Academic Standing.
- Applications for <u>Cross Institutional Study (Exchange)</u> must be assessed and approved by their UNSW Program Authority as equivalent to a UNSW course in terms of content, level and workload.
- Approval must be sort prior to enrolling at the host institution and is at the discretion of the UNSW Program Authority.
- There is no charge for this application.

#### Note:

- In addition to seeking approval from UNSW, a formal application will be required to the host institution.
- Further instructions will be available on receipt of this <u>Cross Institutional Study (Exchange)</u> form approval to the Outbound Short Program Team.
- Acceptance at the host institution is at their discretion and not guaranteed.

#### On completion of the **Short Program - Exchange**

• In order for transfer of credit to be recorded on the UNSW student record, it is the student's responsibility to provide UNSW with official confirmation of the result(s) from the host institution at the completion of the international program.
